Dudley Flood School Desegregation Fellowship

<u>The Dudley Flood Center for Educational Equity and Opportunity</u> (Flood Center) serves as a hub to identify and connect organizations, networks, and leaders to address issues of equity, access, and opportunity in education across North Carolina. The Flood Center aims to inform discussions on policies impacting equity & social justice, supporting and advancing equity-focused educator programming, and promote discussions around how resources are distributed at the local and state levels, in hopes of achieving equity, access, and opportunity for all young people in North Carolina.


The Dudley Flood Center is seeking an Educational Equity Fellow from Summer through Fall 2021 to support Flood Center staff in research and programmatic efforts to achieve its mission and vision. Specifically, this position will focus on the topic of school desegregation efforts in North Carolina after the Brown v. Board Decision.

Primary responsibilities will include:

- Lead/support the Flood Center team in the oral and written history curation of a timeline on school desegregation in North Carolina, including the work of <u>Dr. Dudley Flood</u> after the Board v. Brown decision.
- Support the Flood Center team in collecting research and developing policy recommendations and programmatic efforts around the resegregation of North Carolina Schools. This could include, but is not limited to:
 - Collaborating and providing research and writing for a Policy Brief and/or Op-Ed
 - Planning and support of a Student Voices Webinar session
 - Policy advocacy efforts
 - o Planning and support of a session for the Annual Color of Education Summit
 - Creation of education resources
- Supporting the broader programmatic work of the Dudley Flood Center including the <u>Student Voices</u> <u>Webinar Series</u>, Rural Teacher Leader Network, <u>Color of Education</u>, and other programmatic efforts as needed.
- Other assignments as assigned by the Dudley Flood Center staff.

Qualifications:

Applicants must be enrolled in an undergraduate or graduate program. Strong applicants will have demonstrated experience in oral history curation, an interest in public education, and program development. Applicants should also demonstrate a strong commitment to educational equity and will be eager to learn about education issues in North Carolina. Applicants must also possess strong research and writing skills. **Students who are members of groups underrepresented in careers related to education and policy are especially encouraged to apply.**

Requirements:

Fellows will receive a stipend of \$10,000. The internship will run from July to November 2021. Schedules and hours will be determined at the start of the internship, with a general expectation of 15-20 hours a week. Fellows will be expected to work virtually through August with the possibility of being in person in the fall.
