Statutory Authority

General Statute 115C-270.10

- (a) Fee Schedule The State Board of Education shall establish by rule a schedule of fees for professional educator licensure and administrative changes. The fee established under this section shall not exceed the actual cost of providing the service. The schedule may include fees for any of the following services:
 - 1) Application for demographic or administrative changes to a license
 - Application for a duplicate license or for copies of documents in the licensure files
 - 3) Application for a renewal, extension, addition, upgrade, reinstatement, and variation to a license.
 - 4) Initial application for a new graduate from any recognized educator preparation program.
 - 5) Initial application for an out-of-state applicant.
 - 6) All other applications.

Rationale for Fee Changes

Context

- Based on historical data, the Licensure Office processes approximately 50,000 applications per year.
- Emails to "Ask Licensure" in past year 23,747
- Phone Calls in past year 20,000 25,000
- The Licensure Office employs 10 FTEs as
 Specialists, 2 FTEs as Processing Assistants, 4
 FTEs as Regional Assistance Licensure
 Consultants, and 3 FTEs as Managers/Specialists.

Market Forces

 The role of NCDPI Licensure Specialist is not a closed market. PSUs across the State also employ licensure specialists. There is the potential for competition for qualified personnel.

• The role of licensure specialist is extremely complex, and the volume of work is great.

Budget Considerations

- More direct support to client base is needed (staffing).
 - Clients prefer phone and email support to instructions on the web.
 - Client feedback clearly indicates that better support is needed and improve processing times for applications.
- Technology Enhancements.
 - NCDPI online licensure system is outdated and behind the current technology. Efficiency is not optimal, but the cost of obtaining a more efficient system is greater than budget allows.
 - Legacy processes (paper and microfiche) create the need for better document storage and access which come at increased costs.
