**CSRB Action:** CSRB should discuss and approve any proposed revisions to the charter application in a public meeting. OCS must have an approved application to get to the platform developers in Fall 2026. The 2026 application window will open on Friday, January 30, 2026.

- These revisions are brought to CSRB by OCS after a full review of the existing application and internal discussions regarding areas we often see cause confusion and/or areas that routinely come up in interviews, but are not asked or need clarification in the existing

application. OCS’s goal in CSRB authorizing support is to facilitate a transparent, understandable, and rigorous process that holds charter boards to high expectations resulting in quality charter schools.
