Purpose

- Throughout the summer, as data was available it was shared with local educational leaders for their review and planning
- As of today, all data and reports are publicly available
 - Excel spreadsheets on NCDPI website (school and district level where applicable)
 - Dashboards (test data, school performance grades, and cohort graduation rate)
 - Annual Testing Report
 - Cohort Graduation Report

New for 2024–25 School Year

- Science tests aligned to content standards adopted in July 2023 implemented for grades 5 and 8 and biology
- English Learner (EL) exit standards implemented school year.
 - The English language proficiency assessment's composite score required to exit EL status changed from 4.8 to 4.5.
 - With the implementation of a new assessment, the alternate English language proficiency assessment's score required to exit EL status was set at Performance Level 2.
- In addition to summer program, retest opportunities for not proficient students were available within the school year.

Hurricane Helene

- The loss of instructional days (number) due to Hurricane Helene will be noted on data reports, accountability reports, and the NC Report Card.
- For schools providing end-of-course fall testing, a waiver was granted by the U.S. Department of Education (USED) due to the of loss of instructional days because of Hurricane Helene.
 - Under this waiver, fall end-of-course tests were excluded from school performance grades and the long-term goal calculations.
 - In addition, participation adjustments were applied if schools were unable to test at least 95% of their students in the fall.
 - Three districts and one charter (ten schools total) opted into this waiver.

Positive Notes: 2024–25

- The Four-Year Cohort Graduation Rate increased from 87.0% to 87.7%. This is the third consecutive year of an increase in the four-year rate.
- The percentage of students who were proficient in reading and mathematics tests were the highest in the last 3 years for 12 of the 15 tests.
- Results for all race/ethnicity subgroups were the highest in the last three years (composite).
- All end of grade mathematics tests show an increase in the percentage of students proficient for the current year and the previous two years.

Opportunities

- Improve Grade 3 Reading.
 - Science of Reading Cohorts 1 and 2 outcomes in the 2025–26 school year.
 - Reading comprehension focus
- Improve achievement in reading and mathematics across various subgroups of students.
- With new science assessments' baseline, support instruction, particularly with the inclusion of science and engineering practices.



Statewide Participation Rate






Percent of students proficient on the composite of all grades and subjects by year (2023, 2024, 2025)


Percent of students proficient on the composite of all grades and subjects by year (2023, 2024, 2025)


Grade-Level Proficiency Snapshot

Percent of students college and career-ready proficient by test (2025)



Percent of students grade-level proficient by race/ethnicity and year (2023, 2024, 2025)



Percent of students grade-level proficient by race/ethnicity and year (2023, 2024, 2025)



Percent of students grade-level proficient by grade and year (2023, 2024, 2025)








Percent of students grade-level proficient by race/ethnicity and year (2023, 2024, 2025)



Percent of students grade-level proficient by test (2025)




Science Grades 5 and 8 Composite




ACT Average Composite Score











Average composite score by race/ethnicity and year (2023, 2024, 2025)

Average composite score by student subgroup and year (2023, 2024, 2025)




Percent of students with a composite score of 17 or higher by race/ethnicity (2025)


Percent of students earning silver or higher certificate by year (2023, 2024, 2025)


Percent earning silver or higher certificate by year (2023, 2024, 2025)

Percent of entering ninth-graders graduating high school in four years (2023, 2024, 2025)





Percent of entering ninth-graders graduating high school in four years (2023, 2024, 2025)




Cohort Graduation Rate




Growth Status (20% of SPG)


