## Ending Fiscal Year 2024-2025

- The budget deficit for Fiscal Year 2024-25 is a debt of:
  - \$16.1 million owed to three "big" vendors
  - \$11.3 million (now \$3.4 million) owed to DPI
  - \$2 million owed to WS/FCS Child Nutrition
  - Estimated \$15-20 million owed to "ourselves"
     (WS/FCS) in local, capital and grant funds.

## Beginning Fiscal Year 2025-2026

- Further reductions needed based on:
  - Reduction by \$5 million in State allotments
  - Reduction by \$8 million in federal carryover funds
  - Accounting for \$5 million in local fund balance used in FY25
- Estimated \$18-20 million needed to balance 2025-2026 budget.

#### Office of State Auditor Review

#### What the Audit Found

- Seven findings and one additional assessment
- Overstaffing, not scaling back expenses when pandemic funding expired, and poor financial practices caused \$46.1 million deficit.
- No "malfeasance" no fraud, theft, missing money or referral for criminal investigation
- WS/FCS spent beyond available revenue.
- Fiscal issues date back to 2017

Request for Assistance

#### **WS/FCS** Appeal Request:

Recommend to the State Board of Education that it waive State Board Policy ALOT-002 and the imposition of a 1% penalty on the remaining balance of \$3,409,545.33 that is owed to DPI.

#### **OPTION A**

"The imposition of this penalty places additional financial strain on the district at a time when every available resource is needed to support student achievement, classroom instruction, and critical operational needs. While fiscal responsibility and accountability are important, applying this large a penalty is counterproductive at this time because it diverts funds away from students and into interest costs."

Recommend to the State Board of Education that it assess the monthly penalty but defer any payments on the accrued penalties for a period of 36 months, until September 2028.
