- Financial Noncompliance
 - July 3, 2024 Improved from Financial Non-compliance Disciplinary Status to Probationary Status
 - December 20, 2024 The school is to continue Probationary financial noncompliance for signs of financial insolvency.
 The following financial concerns were noted:
 - (1) The ratio of the comparison of current assets to current liabilities decreased from 0.69 in the FY23 to 0.56 in the FY24, further raising concern about the school's ability to meet its short-term liabilities with its current assets.

Submit annual audits on time.	<no update=""></no>	No update at this time. Annual audits are due in October.
CSDVA board members will go through a minimum of 2 trainings a year.	<no update=""></no>	No update at this time. The CSDVA board will present on progress during scheduled presentation to CSRB.
Provide monthly updates to OCS regarding potential move	At Risk	Updates were provided for May and June. A July update was not initially provided, but the school provided a joint July/August update on August 26, 2025.

- CSDVA was removed from both Governance Non Compliance and Financial Non Compliance



Key Trends Across Schools

- Academic growth remains a challenge for 2 schools. However, all schools under stipulations Met or Exceeded growth for 2024-2025.
- 3 Schools have been placed on Financial Noncompliance while under stipulations. 2 Schools are now removed, and 1 remains.
- Compliance concerns often linked to lack of responsiveness or communication with relevant DPI divisions
- Leadership + Governance Training is largely complete

What's Next

- Paul R. Brown, Next Generation, Rocky Mount Prep, ZECA, and Monroe Charter Academy are all in the 2026 Renewal Cohort.
 - Fall 2025 Schools will be before the Review Board for Renewal Presentations.
 - Early 2026 The Review Board will vote on the Renewal Terms for the 2026 Cohort.
- Community School of Digital and Visual Arts will present at an upcoming CSRB meeting.
