CEP Meal Incentive Program

Section 7.59 of S.L. 2023 – 134 required the North Carolina Department of Public (NCDPI) to establish the Community Eligibility Provision Meal Program Incentive for the 2024 – 2025 fiscal biennium to expand public school participation in the Federally assisted Community Eligibility Provision (CEP) to increase the number of students with access to healthy school meals, including breakfast and lunch, at no cost to students. The incentive program is to be available to eligible public school units for the 2024 –2025 fiscal year.

This report provides information on program activities for the 2024-2025 fiscal year. Since no schools were participating in the program during that fiscal year, this report will provide information on NCDPI activities to establish and launch the program.

FY 2024-2025 CEP Meal Incentive Program Activities

In accordance with Session Law, a public school unit was considered eligible to participate in the incentive program if the school qualified for the CEP but did not participate in the CEP during the 2023 – 2024 fiscal year. The NCDPI developed an application process that included all elements established in Session Law, including the name of the school, the Identified Student Percentage (ISP) for the school for the 2024 – 2025 school year, the projected number of students enrolled in the school for the 2024 – 2025 school year and meal participation rates for breakfast and lunch for the 2024 – 2025 school year. The application enabled the public school units to apply for their eligible school sites to be considered for the meal incentive program. Public school units submitted applications in a timely manner, and the applications were reviewed by the Office of School Nutrition. Data submitted on the application was verified for accuracy using the School Nutrition Technology System, which is the authoritative source for School Nutrition data elements.

Schools were selected for participation in the pilot program in collaboration with the public school units. Public school units were required to make decisions concerning the grouping of eligible schools in order to generate maximum Federal funds from the CEP. Consistent with Session Law, the Office of School Nutrition prioritized the award of CEP Meal Incentive Grant funds to schools with an Identified Student Percentage (ISP) greater than 55%, followed by schools that would draw the greatest amount of Federal CEP funds. Any school selected for the meal incentive program was required to offer innovative breakfast options, including breakfast after the bell and where possible, in the classroom. Grant funds are intended to provide State funding reimbursement that is not funded by Federal school nutrition funds.

Based on the criteria established in Session Law, 157 schools (3 Charters and 154 schools from regular districts) were eligible and approved by the Office of School Nutrition to utilize the CEP Meal Incentive Program funds in SY 2024 – 2025. It is estimated that 48,550 students enrolled in the 157 participating schools who were classified as eligible for paid meals, are now eligible to receive breakfast and lunch meals at school at no cost to the student. The amount of federal and state funding provided to participating public school units and schools received was \$39,943,871 in Federal Lunch and Breakfast Reimbursement and \$3,898,037 in State Incentive Program reimbursement.

In addition, participating schools on average saw small but positive gains in tested subjects from 2024 to 2025. Average assessment scores rose by about 0.5 points. A little over half of schools improved (55%), and roughly 30% posted gains of three points or more. The biggest gains typically came from schools with lower scores in 2024. Results also varied by district, with several (e.g., Stanly, Nash, Dare, Moore) posting noticeably stronger average gains among participating schools. Graduation rates also saw a positive increase. Among the 31 participating high schools with rates reported in both years, the average graduation rate rose from about 85.8% to 86.8%, with the typical school increasing by about 1.6 percentage points.

While these are promising early signals, they're still descriptive and should not be interpreted as evidence of the program's effectiveness. We do not yet separate the effect of the CEP meal incentive program from other local efforts or normal year-to-year shifts. Future analysis should compare these schools to similar, eligible non-participating schools and pair outcomes with changes in breakfast/lunch participation and attendance. Finally, given the limited timeframe, additional years of implementation and analysis will be important to fully understand the potential long-term impact of the CEP meal program incentive on student outcomes.
